TAB 1 Recognition of Service; Kevin Barrett, CRT

Ms. Sherrod called former Board member Mr. Barrett forward to recognize him for his years of dedicated service and expressed the Board's appreciation.

DISCIPLINARY PROCEEDINGS

Due to participation in the Probable Cause Panel, Ms. Nunez was recused from tabs 2 through 4, Mr. Hendriksen was recused from tab 2 and Mr. Fields was recused from tab 3.

MOTION FOR BOARD'S FINAL ORDER AFTER HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

TAB 2 Walter E. Dreeland, RRT, DOH Case No: 2012-12166 Informal Hearing, (PCP - Hendriksen, Nunez)

Respondent was present and sworn in by the court reporter.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violations: Section 468.365 (1)(x), Florida Statutes (2012), through a violation of section 456.072 (1)(hh), Florida Statutes (2012) by failing to successfully complete a drug or alcohol treatment program.

The case was presented as a Hearing Not Involving Disputed Issues of Material Fact, which requires the Board to impose whatever discipline upon the Respondent's license that the Board deems appropriated and to assess costs of the investigation.

MOTION: Ms. Sherrod made a motion to accept the finding that the Respondent was properly served and has requested an informal hearing. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

MOTION: Ms. Sherrod made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

MOTION: Ms. Sherrod made a motion to adopt the materials in this case and any addendum materials into evidence in this proceeding. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

MOTION: Ms. Sherrod made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Respiratory Care Practice Act. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

MOTION: After discussion, Ms. Sherrod made a motion to impose the following penalties:

- Reprimanded
- Fine of \$250.00 to be paid within one (1) year of the filing of the Final Order
- Costs to be paid within one (1) year of the filing of the Final Order
- Suspension of license until Respondent presents a favorable PRN evaluation, stating he
 is able to return to practice with reasonable skill and safety. If recommended by PRN,
 Respondent shall submit proof of execution and compliance with a PRN monitoring
 contract within sixty (60) days of entry of Final Order. The motion was seconded by Mr.
 Fields and carried 4/0.

MOTION: Ms. Sherrod made a motion to assess the costs of \$892.62 to be paid within one (1) year of the filing of the Final Order. The motion was seconded by Mr. Fields and carried 4/0.

MOTION FOR BOARD'S FINAL ORDER BY SETTLEMENT AGREEMENT

TAB 3 Jocelyn A. Atteberry, RRT, DOH Case No: 2012-12346 Settlement Agreement, (PCP Members – Fields, Nunez)

Respondent was not present nor represented by Counsel.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violations: Section 468.365(1)(x), Florida Statutes (2011), through a violation of 456.072(1)(q), Florida Statutes (2011), by violating a lawful order of the Department.

The case was presented as a Settlement Agreement that would impose the following penalties:

- Appearance
- Letter of Concern
- Fine of \$100.00 to be paid within thirty (30) days of the filing of the Final Order
- Costs of \$1618.00 to be paid within twenty (24) months of the filing of the Final Order

He appeared at the July 12, 2013 board meeting to discuss his application. Mr. McGraw's application was denied based on the requirements in Section 456.0635(3)(e), Florida Statutes. "Mr. McGraw is currently listed on the United States Department of Health and Human Services Office of Inspector General's List of Excluded Individuals and Entities."

MOTION: After discussion, Mr. Sherrod made a motion to uphold the denial of Mr. McGraw's licensure due to the requirements in Section 456.0635(3)(e), Florida Statutes. Mr. McGraw is currently listed on the United States Department of Health and Human Services Office of Inspector General's List of Excluded Individuals and Entities. The motion was seconded by Ms. Nunez and carried 6/0.

Petition for Declaratory Statement of Section 468.352, F.S.

Ms. Colon submitted a petition for declaratory statement requesting clarification regarding Chapter 468, Part V, section 468.352, Florida Statutes, related to respiratory care practitioners or respiratory therapists collecting and test other blood samples such as, but not limited to electrolytes or hemoglobin, to assist with the physiologic monitoring of cardiopulmonary patient systems.

MOTION: After discussion, Ms. Sherrod made a motion to decline to answer the declaratory statement as requested due to the statute being clear. The motion was seconded by Ms. Nunez and carried 5/0.

RULES DISCUSSION

TAB 20 Proposals for Rule 64B32-5.006, 64B32-5.007 and 64B32-5.008, Florida Administrative Code (F.A.C.)

The Bureau of Enforcement requests the Board of Respiratory Care amend the following rules to allow resolution of additional violations by mediation and citation. These changes are proposed to increase mediation authority for minor violations, thus eliminating costs of service, investigation, prosecution, and compliance for successful mediation, as well as change citation authority for second time violations or instances where mediation is unsuccessful. In addition, with the CE@Renewal changes, this allows mediation for continuing education violations until continuing education is required to be documented for renewal, and eliminates the citation rules regarding continuing education:

64B32-5.006 – **Mediation** 64B32-5.007 – **Citations** 64B32-5.008 - **Notice of Noncompliance**

MOTION: After discussion, Ms. Sherrod made a motion to accept the proposed concept for rules 64B32-5.006, 64B32-5.007 and 64B32-5.008, F.A.C., directing Board Counsel to research and bring findings to the next board meeting. The motion was seconded by Ms. Grassi and carried 6/0.

Rules may be adopted limiting the time an individual has to address the Board; allowing representatives of groups or factions speak rather than all members to speak; and designating a specified period of time for public comments.

64B- Public Comment.

The Board of <u>Respiratory Care</u> invites and encourages all members of the public to provide comment on matters or propositions before the Board or a committee of the Board. The opportunity to provide comment shall be subject to the following:

- (1) Members of the public will be given an opportunity to provide comment on subject matters before the Board after an agenda item is introduced at a properly noticed board meeting.
- (2) Members of the public shall be limited to <u>10</u> minutes to provide comment. This time shall not include time spent by the presenter responding to questions posed by Board members, staff or board counsel. The chair of the Board may extend the time to provide comment if time permits.
- (3) Members of the public shall notify board staff in writing of his or her interest to be heard on a proposition or matter before the Board. The notification shall identify the person or entity, indicate support, opposition, or neutrality, and identify who will speak on behalf of a group or

faction of persons consisting of $\underline{3}$ or more persons. Any person or entity appearing before the Board may use a pseudonym if he or she do not wish to be identified.

Mr. Dolan will bring language to the next board meeting for the Board review regarding public meetings.
