# MOTION FOR BOARD'S FINAL ORDER BY SETTLEMENT AGREEMENT

Respondent was present and sworn in by the court reporter.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violation: Section 468.365 (1)(x), Florida Statutes (2011), through a violation of 456.072(1)(q), Florida Statues (2011), by violating a lawful order of the department.

**TAB 23** Peter E. Bernat, RRT, DOH Case No: 2013-18658 Informal Waiver/Default, (PCP Members – Fields and Barrett)

Respondent was not present nor represented by Counsel.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violations: **Count 1:** Section 456.365 (1)(x), through 456.072 (1)(x), Florida Statutes (2008) by failing to report to the board, in writing within 30 days after the licensee has been convicted or found guilty of, or entered a plea of nolo contendere to, regardless of adjudication, a crime in any jurisdiction constitutes grounds for discipline by the Board of Respiratory Care. **Count 2:** Section 468.365 (1) (x), through 456.072 (1)(x), Florida Statutes (2009), by failing to report the referenced plea/conviction to the board or department within 30 days.

He has submitted an application for Exemption from Disqualification to seek employment in a health care facility licensed under Chapter 400, Florida Statutes.

**MOTION:** After discussion, Mr. Hendriksen made a motion to grant Mr. Richard's request for an Employment Exemption from Disqualification. The motion was seconded by Mr. Fields and carried 4/1. Ms. Sherrod opposed.

# RECONSIDERATION

### TAB 25 Nicole Rivera, Certified Respiratory Therapist

Ms. Rivera was initially reviewed by the board at the July 11, 2014 board meeting and was approved with conditions. The conditions were met, however, prior to the issuance of her license, staff requested clarification to the following question and "yes" answer on her application: "Have you been convicted of, entered a plea of guilty or nolo contendere to, regardless of adjudication, a felony under 21 U.S.C ss. 801-970 (relating to controlled substances) or 42 U.S.C. ss 1395-1396 (relating to public health, welfare, Medicare and Medicaid issues)?"

Ms. Rivera responded she had been convicted under 42 U.S.C for public assistance and Medicaid fraud. Staff has requested supporting documentation but has not received any affirmative documentation or proof to show whether or not she was convicted under this specific statute.

The application was brought before the Board for reconsideration.

**MOTION:** Ms. Sherrod made a motion reconsider the application. The motion was seconded by Dr. Friday and carried 5/0.

**MOTION:** Ms. Sherrod made a motion to vacate the Notice of Intent to Approve With Conditions. The motion was seconded by Ms. Nunez and carried 5/0.

**MOTION:** Further, Ms. Sherrod made a motion to deny licensure due to possibly having a disqualifying offense under Section 456.0635, F.S. The motion was seconded by Mr. Hendriksen and carried 5/0.

If Ms. Rivera decides to apply for licensure in the future, she would need to provide affirmative proof that she was not convicted under a statute that is listed as a disqualifying offense under Section 456.0635, F.S.

# **RULE DISCUSSION**

# TAB 14 Continuing Education Requirements

During the July board meeting, discussion was had to clarify continuing education requirements. The following questions were answered:

• Is it the Board's intention to require the Laws and Rules course for the first renewal for licensees licensed in the second half of the biennium?

The Board's intent is yes

• Are licensees restricted to only two hours of Laws and Rules?

The Board's intent is yes

• Are licensees allowed credit for the same course taken twice on different dates within the same biennium?

The Board agreed that credit should not be allowed for the same course taken more than once.

• Are the excess hours of HIV/AIDS considered non-direct or direct hours?

Excess hours are considered direct and the Board's intent is to make the excess hours received for HIV/AIDS language consistent will the other mandatory hours.

• Can attendance at a respiratory care board meeting hours earned count towards the two hours of Florida Laws and Rules?

The intent of the Board's is yes.

Board Counsel has drafted the included language to provide clarification.

# 64B32-6.001 Continuing Education Requirement.

#### (1) - (2) No Change

(3) Those persons initially licensed during the second year of a biennium who do not currently hold a respiratory care license are exempt from the continuing education requirements, except for the Medical Errors course and HIV/AIDS course pursuant to subsection (5) of this rule and Section 456.033, F.S., and the Florida laws and rules course, for their first renewal. Continuing education requirements must be met for each biennium thereafter.

(4) No Change

(5) Beginning with the biennium ending May 31, 2015, a licensee needs twenty-four (24) hours per biennium in order to renew the license, of which (2) credit hours must include Florida laws and rules to bring the licensee up to date on laws and rules of the Board and the regulatory agency under which the Board operates.

The hours can be obtained in the following manner:

(6) No Change

(7) <u>No licensee will be given more than the credited hours of completion of any continuing education</u> <u>course</u>, as credited for completion of the course once, per biennium, regardless of the number of times a <u>licensee registers for and completes a course</u>.

#### 64B32-6.004 Procedures for Approval of Attendance at Continuing Education Courses.

(1) No Change

(2) Excluding any recertification, review, refresher, or preparatory courses, all licensees shall be awarded contact hours for:

(a) – (f) No Change

(g) Attendance at scheduled public meetings of the Board of Respiratory Care, up to a maximum of 8 continuing education direct <u>deliverypatient care</u> hours per biennium.

(3) A minimum of 16 hours each biennium must be obtained by each licensee in approved offerings

related to the direct delivery of respiratory care services. No more than 8 hours of nondirect patient care continuing education in the areas of management, risk management, personal growth, and educational techniques will be acceptable for the purpose of biennial renewal of a license. Up to 12 hours per biennium may be home study courses.

(a) Beginning with the biennium ending May 31, 2009, each licensee will be required to have taken a continuing education course in emergency preparedness. This course shall count as two (2) hours of direct patient care credit. This course shall be taken each biennium thereafter and the two (2) hours credit shall count towards the minimum sixteen (16) hours needed to renew the license.

(a)(b) Credit for two (2) hours of direct patient care shall be awarded for completion of a FEMA Emergency Management/ Preparedness continuing education course that complies with the requirements set forth in rule paragraph (3)(c).

(b)(c) Continuing education courses in emergency preparedness, at a minimum, must cover the following topics: natural disasters, manmade disasters and bioterrorism, pandemic flu, and respiratory care disaster response.

(4) - (6) No Change

#### 64B32-6.006 AIDS Education and Medical Error Prevention Education.

Pursuant to Section 456.033, F.S., any Category I, American Medical Association (AMA) continuing medical education course, any Category I or Category III, American Association for Respiratory Care (AARC) continuing education course offered by an AMA approved respiratory therapy program and any courses approved by any board within the Division of Medical Quality Assurance of the Department of Health pursuant to Section 456.033, F.S., which includes topics on the transmission, infection control procedures, clinical management and prevention of Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome, shall satisfy the requirements of Section 456.033, F.S., as part of the first renewal of the license. Such course shall include information on current Florida law on acquired immune deficiency syndrome and its impact on testing, confidentiality of test results, treatment of patients, and any protocols and procedures applicable to human immunodeficiency virus counseling and testing, reporting, the offering of HIV testing to pregnant women, and partner notification issues pursuant to Sections 381.004 and 384.25, F.S.

(1) The required AIDS education can be completed with one course divided in incremental blocks of time, as long as each increment is at least one contact hour in length and the cumulative total equals a minimum of 3 contact hours, and all of the topics stated above are covered; or by one course which is at least 3 contact hours in length and covers all of the topics stated above; or by multiple courses which are each at least 1 contact hour in length and each cover all of the topics stated above. Licensees may complete up to 5 hours of continuing education credited to AIDS education, and any completed hours in excess of the required 3 hours will be counted as direct delivery continuing education credits. New licensees must complete three contact hours taken within the last five years prior to either initial licensure or first renewal. (2) – (4) No Change

**MOTION:** After discussion, Ms. Sherrod made a motion to approve the draft language and directed counsel to move forward with rulemaking procedures. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

The Statement of Estimated Regulatory Cost was analyzed during the July 2014 meeting when language was initially proposed.

Mr. Dolan asked the board if they would like the continuing education rule to be cleaned up and simplified.

**MOTION:** After discussion, Ms. Sherrod made a motion to direct counsel to draft revised language to simplify the rule and to ensure consistent terminology. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

The board also suggested updating the list of approved NBRC certifications.
