MOTION FOR BOARD'S FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

1. Max Geotina Abellana, Jr., R.R.T., Case No: 2016-22542 (PCP, Frey & Fields)

Respondent was present and sworn in by the court reporter.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violation: Section 468.365 (1)(i), Florida Statutes (2014), by violating a lawful order of the Board previously entered in a disciplinary hearing.

The case was presented as a Hearing Not Involving Disputed Issues of Material Fact, which requires the Board to impose whatever discipline upon the Respondent's license that the Board deems appropriated and to assess costs of the investigation.

MOTION: Dr. Friday-Stroud made a motion to accept the investigative report into evidence for imposing penalties, made a finding that the Respondent was properly served and has requested an informal hearing, adopted the findings of fact and conclusions of law as set forth in the Administrative Complaint, and found that this constitutes a violation of the Respiratory Care Practice Act. The motion was seconded by Mr. Colon and carried 5/0.

MOTION: After discussion, Dr. Friday-Stroud made a motion to impose the following penalties:

- Reprimand
- Fine of \$300.00 to be paid within one (1) year of the filing of the Final Order
- Costs of \$21.49 to be paid within 90 ninety days of the filing of the Final Order
- The Respondent's license to practice respiratory care in the State of Florida shall be SUSPENDED until he complies with the terms of the Final Order entered in case number 2011-20345.

The motion was seconded by Mr. Mitchell and carried 4/1. Mr. Colon opposed.

MOTION FOR BOARD'S FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT AND DETERMINATION OF RESPONDENT'S WAIVER OF RIGHT TO REQUEST A FORMAL HEARING

2. Frank A. Fernandez, R.R.T., Case No: 2015-30728 (PCP, Frey & Fields)

Respondent was not present nor represented by Counsel.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violations: **Count 1)** Section 458.365 (1)(w), Florida Statutes (2016), for being unable to deliver respiratory care services with reasonable skill and safety to patients by reason of illness or use of alcohol, drugs, narcotics, chemicals, or any other type of material as a result of any mental or physical condition. **Count 2)** Section 458.365 (1)(r), Florida Statutes (2014-2016), for making deceptive, untrue, or fraudulent, representations in the delivery of respiratory care services or employing a trick or scheme in the delivery of respiratory care services if such scheme or trick fails to conform to the generally prevailing standards of other licenses within the community.

The case was presented as a Hearing Not Involving Disputed Issues of Material Facts and determination of Respondent's waiver of right to request an informal hearing by default.

MOTION: Dr. Friday-Stroud made a motion to accept the investigative report and exhibits into evidence for the purposes of imposing penalty, making a finding that the Respondent was properly served and has waived his right to a formal hearing, adopted the findings of fact and

conclusions of Law as set forth in the Administrative Complaint and that this constitutes a violation of the Florida Statutes, as set forth in the Administrative Complaint. The motion was seconded by Mr. Colon and carried 5/0.

MOTION: After discussion, Mr. Colon made a motion to impose the following penalties:

- Renovation for Respondent's license
- Costs of \$1,890.88 to be paid within 90 days of the filing of the Final Order

The motion was seconded by Dr. Friday-Stroud and carried 5/0.

3. Robert L. Shouse, R.R.T., Case No: 2016-14556 (PCP, Frey & Fields)

Respondent was not present nor represented by Counsel.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violations: **Count 1**: Section 458.365 (1)(w), Florida Statutes (2016), for being unable to deliver respiratory care services with reasonable skill and safety to patients by reason of illness or use of alcohol, drugs, narcotics, chemicals, or any other type of material as a result of any mental or physical condition. **Count 2**: Section 458.072 (1)(aa), Florida Statutes (2015-2016) by testing positive for cocaine and fentanyl on a PPH-ordered drug screen without lawful prescriptions or legitimate medical reasons for using the drugs.

The case was presented as a Hearing Not Involving Disputed Issues of Material Facts and determination of Respondent's waiver of right to request an informal hearing by default.

MOTION: Mr. Colon made a motion to accept the investigative report into evidence for imposing penalties, made a finding that the Respondent was properly served and has requested an informal hearing, adopted the findings of fact and conclusions of law as set forth in the Administrative Complaint and found that this constitutes a violation of the Respiratory Care Practice Act. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

MOTION: After discussion, Dr. Friday-Stroud made a motion to impose the following penalties:

- The Respondent's license to practice respiratory care in the State of Florida shall be SUSPENDED until he has been determined to be safe to practice by the board.
- After Respondent's license is reinstated his license will be on probation for one year with conditions to be determined by the board.
- Costs of \$2,040.46 to be paid within one year of the filing of the Final Order.
- Fine of \$600.00 to be paid within one year of the filing of the Final Order.

The motion was seconded by Mr. Broeker and carried 5/0.

DISCIPLINARY VOLUNTARY RELINQUISHMENT

24. Jack S. Socha, C.R.T., Case No: 2015-31025 (PCP, N/A)

Respondent was not present nor represented by Counsel.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violation: Section 456.072(1)(k)(v)(dd), Florida Statutes; Section 468.365(1)(l)(o)(q)(x), Florida Statutes.

The case was presented as a motion of Board's Final Order by Voluntary Relinquishment.

MOTION: After discussion, Mr. Frey moved to accept the Voluntary Relinquishment.

The motion was seconded by Mr. Mitchell and carried 6/0.

PERSONAL APPEARANCE PURSUANT TO §456.013(3)(c), F.S.

6. Chadrick Herrin, Certified Respiratory Therapist

Mr. Herrin was not present nor represented by Counsel.

He was requested to appear before the board due to the "yes" answer in the disciplinary history section of his application.

Mr. Herrin has failed to appear at the October 14, 2016 and February 10, 2017 board meetings. Mr. Herrin was issued an Order requiring his appearance at the April 7, 2017 meeting or his application shall be denied.

MOTION: After discussion, Mr. Frey made a motion to deny licensure due to failure to comply with an Order by the Florida Board of Respiratory Care. The motion was seconded by Mr. Garcia and carried 6/0.

6. Douglas Edward Wilkinson, Registered Respiratory Therapist

Mr. Wilkinson was present and sworn in by the court reporter.

He was requested to appear before the board due to the "yes" answer in the Criminal history section of his application.

MOTION: After discussion, Dr. Friday-Stroud made a motion to grant licensure with no conditions. The motion was seconded by Mr. Frey and carried 6/0.

11. Sunshine Law Review

Board Counsel provided a brief overview of the Sunshine Law.

12. Voting Conflicts

Form 8A, Memorandum of Voting Conflict for State Officers, is to be completed by any person serving at the State level of government on an appointed or elected board, council, commission, authority, committee, or as a member of the Legislature. It applies to members of advisory and non-advisory bodies who are presented with a voting conflict of interest under Section 112.3143, Florida Statutes.

This form is required in instances where a board/council member is recused due to a financial conflict.

The form was provided for the Board's review and will be available from staff, in the event a member should recuse themselves under such circumstances.

The Assistant Attorney General addressed questions regarding the form and inquiries related to the need for recusal.

MOTION: After Discussion, Mr. Frey made a motion to accept the proposed 2018 Board business meeting dates. The motion was seconded by Mr. Broeker and carried 6/0.

The Board determined all Probable Cause Panel meetings will begin at 8:00 a.m.

Mr. Craig Broeker was appointed for the first threes Probable Cause Panel meeting and Mr. Ruben Colon will serve for the last three meetings in 2018.

14. Unlicensed Activity Outreach

The Division of Medical Quality Assurance is looking for opportunities to improve communication on Unlicensed activity and are asking Boards and Councils to provide input/suggestions as to outreach opportunities for the ULA program.

Mr. Hall provided a brief overview of the Unlicensed Activity Outreach program and inquired from the Board ideas to help can the word out.

15. Designation of Minor Violations

In the 2016 Legislative Session, HB 183 was passed. One of the provisions of this legislation was an amendment to section 120.695, F.S., related to the designation of minor violations.

The legislation provided in part:

- (b) Each agency shall review all its rules and designate those for which a violation would be a minor violation and for which a notice of noncompliance must be the first enforcement action taken against a person or business subject to regulation. A violation of a rule is a minor violation if it does not result in economic or physical harm to a person or adversely affect the public health, safety, or welfare or create a significant threat of such harm.
- (C) 1. No later than June 30, 2017, and after such date within 3 months after any request of the rules ombudsman in the Executive Office of the Governor, each agency shall review its rules and certify to the President of the Senate, the Speaker of the House of Representatives, the committee, and the rules ombudsman those rules that have been designated as rules the violation of which would be a minor violation.

Each Board has a Notice of Noncompliance rule that specifies which violations are considered a minor violation. In order to comply with the June 30, 2017, deadline each profession was asked to review their rules and determine if any additional violations should be noted as a minor violation.

At this time, Mr. Max Geotina Abellana appeared at the meeting and requested to address the Board regarding tab one.

Motion: Mr. Colon made a motion to not reconsider the agenda item and move forward with penalties imposed. The motion was seconded by Mr. Mitchell and carried 4/1. Dr. Friday-Stroud opposed.

Mr. Frey discussed the new agenda item that will be placed on the July 2017 Board agenda. The Board indicated the title of the agenda should be, "The Future of Respiratory Licensure in Florida within Statuary Guidelines".

The Board Counsel provided comments to the Board regarding the letter received from the Joint Administrative Procedures Committee (JAPC).

MOTION: Dr. Friday-Stroud made a motion carried authorizing a **publication of a Notice of Change**, whereas the Board delegated authority to board counsel (Ms. Munson) to make **all** necessary changes pursuant to the information identified in the JAPC letter dated March 27, 2017. The proposed changes approved by the Board included adding the applicable citations to <u>Rule 64B32-5.001</u>, <u>FA.C.</u>, as referenced for *rulemaking authority* and *as laws implemented*. Additionally, pursuant to the references in the JAPC letter, the following changes were approved by the Board:

- Make the recommended citation corrections to Rules 64B32-5.001(3)(q)(w)(x)(z)(aa)(cc), F.A.C.; and
- Include a disclaimer to Rules 64B32-5.001(3)(dd)(ee), F.A.C., acknowledging that the summaries of the violations are descriptive only with instructions to refer to the full text of the statute or the rule for to full text of the violation; and
- Include a brief description of the offense in the disciplinary guidelines because some have a statutory cite without a description regarding Rules 64B32-5.001(3)(gg)(ii), F.A.C.

The motion was seconded by Mr. Colon and carried 6/0.

MOTION: Dr. Friday-Stroud made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to increase regulatory costs directly or indirectly to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Mr. Frey and carried 6/0.

MOTION: Mr. Frey made a motion to find the proposed affected cumulative changes would not be to increase regulatory costs to any entity (including government) in excess of \$1,000,000 in Florida within the next 5 years after the implementation of the rule. The motion was seconded by Mr. Colon and carried 6/0.

The Board Counsel provided another comments to the Board regarding the letter received from the Joint Administrative Procedures Committee (JAPC), regarding Rule 64B32-6.004, F.A.C., because standards may change from time to time, include an effective on or before date of the offerings. And consideration of statutory authority for the continuing education credits being inquired for Section (2) and Section (5), regarding the statutory authority for current board members and provide a publication of a Notice of Change.

Motion: After discussion, Mr. Colon made a motion regarding Rule to approve the following changes to Rule 64B32-6.004, F.A.C., authorizing a **publication of a Notice of Change**, whereas the board delegated authority to board counsel (Ms. Munson) to make **all** approved changes in response to the information identified in the JAPC letter dated March 31, 2017. The proposed changes approved by the Board included adding the applicable citation to <u>Rule 64B32-6.004</u>, FA.C., as referenced for *rulemaking authority* and *as laws*

implemented. Additionally, pursuant to the references in the JAPC letter, the following changes were approved by the Board:

- Add language to the approval standards referenced in Rules 64B32-6.004(2)(a)(b), F.A.C. and Rule 64B32-6.004(3), F.A.C., to provide a date for which the continuing education offered by the provider is effective. The effective date to be included in the rules referenced, as determined by the board, is: "on or before April 1, 2017;" and
- Delete <u>Rule 64B32-6.004(2)(f)</u>, <u>F.A.C.</u>, regarding continuing education for recredentialing examinations; and
- Change language in <u>Rule 64B32-6.004(2)(g)</u>, <u>F.A.C.</u>, to state that the licensee receives continuing education in risk management by attending a meeting of the board where discipline is on the agenda; and
- Change language in <u>Rule 64B32-6.004(5)</u>, <u>F.A.C.</u>, to reflect **5 hours in risk** management (not medical errors) for former Board members.

MOTION: Mr. Frey made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to increase regulatory costs directly or indirectly to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule.
