DISCIPLINARY PROCEEDINGS

MOTION FOR BOARD'S FINAL ORDER BY DISCIPLINARY VOLUNTARY RELINQUISHMENT

1. **Kevin Jacobs, RRT, (PCP: Frey and Barrett)**

Respondent was not present.

Mr. Frey is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: Section 456.072 (1) (aa), Florida Statutes (2020), subjects a licensee to discipline for testing positive for any drug, as defined by section 112.0455, on any confirmed pre-employment or employer-ordered drug screening when the practitioner does not have a lawful prescription and legitimate medical reason for using the drug.

The case was presented as a motion of Board's Final Order by Voluntary Relinquishment.

MOTION: After discussion, Mr. Mitchell moved to accept the Voluntary Relinquishment. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

MOTION FOR HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACTS AND FINAL ORDER

2. Max G. Abellana, Jr., RRT, (PCP: Hom and Nunez)

Respondent was not present.

Ms. Hom is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: Section 456.072 (1)(q), Florida Statutes (2017), provides that violating a lawful order of the department or the board, or failing to comply with a lawfully issued subpoena of the department constitutes grounds for discipline.

The case was presented as a Hearing Not Involving Disputed Issues of Material Facts and determination of Respondent's waiver of right to request an informal hearing by default.

MOTION: Dr. Friday-Stroud made a motion to accept the investigative report and exhibits into evidence for the purposes of imposing penalty, making a finding that the Respondent was properly served and has waived his right to a formal hearing, adopted the findings of fact that is set forth in the Administrative Complaint. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: Dr. Friday-Stroud made a motion to adopt the conclusions of Law as set forth in the Administrative Complaint and that this constitutes a violation of the Practice Act. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: After discussion Dr. Friday-Stroud made a motion to impose the following penalties:

Respondent's license is suspended until compliant.

The motion was seconded by Mr. Mitchell and carried 4/0.

MOTION: Dr. Friday-Stroud made a motion to access the costs of \$79.34 to be paid within 1 year of the filing of the Final Order. The motion was seconded by Mr. Michell and carried 4/0.

MOTION: After discussion, Mr. Mitchell moved to accept the petition for reinstatement. The motion was seconded by Dr. Friday-Stroud and carried 4/0.

5. Amanda Silvas, RT 10700

MOTION: After discussion, Mr. Mitchell moved to reinstate Ms. Silvas license and accept the CE's that were present at the meeting. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: After discussion, Mr. Mitchell made a motion to deny licensure. The motion was seconded by Mr. Garcia and carried 5/0.

9. Marco Valdez, Registered Respiratory Therapist

Mr. Valdez was not present.

The Board Chair required Mr. Valdez's appearance at the January 14, 2022, meeting where he was not in attendance. On January 27, 2022, he received an Order Requiring his Appearance at the April 8, 2022, meeting.

MOTION: After discussion, Mr. Mitchell made a motion to waive the required appearance and grant licensure with no conditions. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

10. Devin A. Cutting, Registered Respiratory Therapist

Ms. Cutting was not present.

The Board Chair required Ms. Cutting's appearance due to there not being a personal statement regarding the incident on file. A notice to appear was sent on January 20, 2022.

MOTION: After discussion, Mr. Mitchell made a motion to deny licensure. The motion was seconded by Mr. Garcia.

Motion Failed and was withdrawn.

MOTION: After discussion, Mr. Frey made a motion to require Mrs. Cutting's appearance at the regularly scheduled Board meeting on July 15, 2022. The motion was seconded by Ms. Hom and carried 4/1. Mr. Mitchell opposed.

- Applicant shall contact the Florida Professionals Resource Network (PRN) within 30 days, undergo an evaluation coordinated by PRN within 60 days of the filing of the Order and if recommended, comply with any and all terms or conditions imposed by PRN within 90 days of the filing of the Order as a result of said evaluation.
- Staff may issue license if PRN deems applicant safe to practice, or if she does not comply, the application will be denied.
