DISCIPLINARY PROCEEDINGS

SETTLEMENT AGREEMENT

1. Madeline Marie Johnson, CRT, (PCP: Frey and Barrett)

Respondent was not present but represented by council, Jessica Herzing who was sworn in by the court reporter.

Mr. Frey is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: Section 468.365 (1) (f), Florida Statutes (2019), provides that unprofessional conduct, which includes, but is not limited to, any departure from, or failure to conform to, acceptable standards related to the delivery of respiratory care services, as set forth by the board in rules adopted pursuant to this part, constitutes grounds for disciplinary action. Rule 64B32-5.003(2), Florida Administrative Code, defines acceptable standards as practicing respiratory care with the level of care, skill, and treatment which is recognized by a reasonably prudent respiratory therapist as being acceptable under similar conditions and circumstances.

The case was presented as a Settlement Agreement that would impose the following penalties:

- Reprimand
- Administrative fine of \$300.00.
- Costs of \$1,576.19 to be paid within three (3) years of the filing of the Final Order
- Respondent shall enroll and successfully complete within 6 months of the Final Order, the following continuing education: Ethics (2 hours), Medical Error Prevention (2 hours), Critical Thinking (8 hours) and Tracheotomy and Medical Ventilation (8 hours).

MOTION: Mr. Mitchell made a motion to accept the Settlement Agreement. The motion was seconded by Mr. Garcia and carried 4/0.

MOTION FOR DETERMINATION OF WAIVER AND FOR FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

2. Donald Chung, RRT, (PCP: Friday-Stroud and Nunez)

Respondent was not present and sworn in by the court reporter.

Dr. Friday-Stroud is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: Section 456.072(1) (a), Florida Statutes (2020), which subjects a licensee to discipline for testing positive for any drug, as defined in section 112.0455, on any confirmed pre-employment or employer-ordered drug screening when the practitioner does not have a lawful prescription and legitimate medical reason for using the drug.

The case was presented as a motion for determination of waiver and final order by hearing not involving disputed issues of material fact.

MOTION: Ms. Hom made a motion to accept the investigative report and exhibits into evidence for the purposes of imposing penalty, making a finding that the Respondent was properly served and has waived his right to a formal hearing, adopted the findings of fact that is set forth in the Administrative Complaint. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: Ms. Hom made a motion to adopt the conclusions of Law as set forth in the Administrative Complaint and that this constitutes a violation of the Practice Act. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: After discussion Ms. Hom made a motion to impose the following penalties:

• Suspended until compliant with PRN.

The motion was seconded by Mr. Frey and carried 4/0.

MOTION: Ms. Hom made a motion to access the costs of \$1,463.18 to be paid within two (2) years of the filing of the Final Order. The motion was seconded by Mr. Frey and carried 4/0.

MOTION: After discussion, Ms. Hom made a motion to deny licensure. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

5. Tammy Houston, Registered Respiratory Therapist

Ms. Houston was present and sworn in by the court reporter.

10. Adrianne Erin Arnold, Registered Respiratory Therapist

The Board Chair required Ms. Arnold's appearance. She was sent a notice to appear on June 22, 2022.

MOTION: After discussion, Dr. Friday-Stroud made a motion to table this application until the next meeting and require Ms. Arnold's appearance at the regularly scheduled Board meeting on October 7, 2022. If she does not appear her application will be denied. The motion was seconded by Mr. Mitchell and carried 5/0.

11. Rebecca Rose, Registered Respiratory Therapist

Ms. Rose was not present.

Board Staff has reached out to Ms. Rose on numerous attempts to regarding the "yes" answer to the following question:

For the felonies of the third degree under s. 893.13(6)(a), Florida Statutes, has it been more than 5 years from the date of the plea or conviction, and completion of any sentence or subsequent period of probation?

We have not received information regarding this charge, if any, or a corrected application.

MOTION: After discussion, Mr. Mitchell made a motion to table this application until the next

meeting and require Ms. Rose's appearance at the regularly scheduled Board meeting on October 7, 2022. If she does not appear her application will be denied. The motion was seconded by Mr. Garcia and carried 5/0.

12. James Sampson, Certified Respiratory Therapist

- Applicant shall make contact with the Florida Professionals Resource Network (PRN) within 30 days, undergo an evaluation coordinated by PRN within 60 days of the filing of the Order and if recommended, comply with any and all terms or conditions imposed by PRN within 90 days of the filing of the Order as a result of said evaluation.
- Staff may issue license if PRN deems applicant safe to practice, or if he does not comply, the application will be denied.

The motion was seconded by Dr. Friday-Stroud and carried 5/0.

EXEMPTION FROM EMPLOYMENT DISQUALIFICATION

15. Vladimir Cadely, RT 15437

He applied for Exemption from Disqualification to seek employment in a health care facility licensed under Chapter 400, Florida Statutes.
