DISCIPLINARY PROCEEDINGS

MOTION FOR DETERMINATION OF WAIVER AND FOR FINAL ORDER AFTER A HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

1. India Bryant, RRT, (PCP: Friday-Stroud and Nunez)

Respondent was not present nor represented by council.

Dr. Friday-Stroud is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: **Count I:** Section 468.365 (1) (g), Florida Statutes (2020), provides that engaging or attempting to engage in the possession, sale or distribution of controlled substances, as set forth

by law, for any purpose other than a legitimate purpose, constitutes grounds for discipline. **Count II:** Section 456.072 (1) (q), Florida Statutes (2020), provides that violating a lawful order of the department or the board, or failing to comply with a lawfully issued subpoena of the department, constitutes grounds for discipline.

The case was presented as a motion for determination of waiver and final order after a hearing not involving disputed issues of material fact.

MOTION: Mr. Frey made a motion to accept the investigative report and exhibits into evidence for the purposes of imposing penalty, making a finding that the Respondent was properly served and has waived his right to a formal hearing, adopted the findings of fact that is set forth in the Administrative Complaint. The motion was seconded by Ms. Hom and carried 4/0.

MOTION: Mr. Frey made a motion to adopt the conclusions of Law as set forth in the Administrative Complaint and that this constitutes a violation of the Practice Act. The motion was seconded by Ms. Hom and carried 4/0.

MOTION: After discussion Mr. Mitchell made a motion to impose the following penalties:

- Administrative fine of \$1,000
- Suspension until evaluation by PRN approved evaluator
- Compliance with recommendations followed by probation for 2 years with direct supervision
- CE-Legal Aspects (8 hours)
- Ethics (8 hours)

The motion was seconded by Ms. Hom and carried 4/0.

MOTION: Mr. Mitchell made a motion to access the costs of \$2,846.72 to be paid within 2 years of the filing of the Final Order. The motion was seconded by Ms. Hom and carried 4/0.

MOTION FOR BOARD'S FINAL ORDER BY DISCIPLINARY VOLUNTARY RELINQUISHMENT

2. Ashley M. Adams, RRT, (PCP: Friday-Stroud and Weiss)

Respondent was not present nor represented by council.

Dr. Friday-Stroud is recused due to participation in Probable Cause Panel.

Mr. Crawford summarized the case for the Board. Respondent was charged with the following violation: **Count I:** Section 456.072(1) (c), Florida Statutes (2021), provides that being convicted or found guilty of, or entering a plea of guilty or nolo contendere to, regardless of adjudication, a crime in any jurisdiction which relates to the practice of, or the ability to practice, a licensee's profession, constitutes grounds for disciplinary action. **Count II:** Section 456.072 (1) (II), Florida Statutes (2021), provides being convicted of, or entering a plea of guilty or nolo contendere to, any misdemeanor or felony, regardless of adjudication, a crime in any jurisdiction which relates to health care fraud, constitutes grounds for disciplinary action.

The case was presented as a motion of Board's Final Order by Voluntary Relinquishment.

MOTION: After discussion, Mr. Mitchell made a motion to accept the Voluntary Relinquishment. The motion was seconded by Mr. Frey and carried 4/0.

4. Ameshia Walker-Smith, Registered Respiratory Therapist

Ms. McElwain received an Order Requiring her appearance at the October meeting on August 24th, 2022.

MOTION: After discussion, Mr. Frey made a motion to deny licensure. The motion was seconded by Mr. Garcia and carried 5/0.

6. Adrianne Erin Arnold, Registered Respiratory Therapist

The Board Chair required Ms. Arnold's appearance.

She was not in attendance at the July meeting and was sent an Order Requiring her Appearance at the October meeting on August 24, 2022.

has not been convicted under 893.13(6)(a), Florida Statutes.

MOTION: After discussion, Dr. Friday-Stroud made a motion to allow one last opportunity to appear at the January 2023 meeting. The motion was seconded by Mr. Mitchell and carried 5/0.

8. Desiree Pitts, Registered Respiratory Therapist

Ms. Pitts was present.

The Board Chair required Ms. Pitt's appearance.

She was sent a notice to appear on July 29, 2022.

MOTION: After discussion, Dr. Friday-Stroud made a motion to grant licensure without conditions. The motion was seconded by Mr. Mitchell and carried 5/0.

9. April Dawn Byrd, Registered Respiratory Therapist

Ms. Byrd was not present.

Ms. Byrd was noticed to appear on August 24, 2022.

MOTION: After discussion, Dr. Friday-Stroud made a motion to notice appearance at the January 2023 meeting. The motion was seconded by Mr. Garcia and carried 5/0.

10. Kevin Byrd, Registered Respiratory Therapist

Mr. Byrd was present.

The Board Chair required Mr. Byrd's appearance at the October 14, 2022, meeting.

MOTION: After discussion, Dr. Friday-Stroud made a motion to grant licensure without conditions.. The motion was seconded by Mr. Mitchell and carried 5/0.

11. Racheall Lengacher, Registered Respiratory Therapist

Ms. Lengacher was present.

The Board Chair required Ms. Lengacher appearance at the October 14, 2022, meeting.

MOTION: After discussion, Mr. Frey made a motion to grant licensure without conditions. The motion was seconded by Mr. Garcia and carried 5/0.

12. Ashlyn Pikelny, Registered Respiratory Therapist

Ms. Pikelny was present.

The Board Chair required Ms. Pikelny appearance at the October 14, 2022, meeting, at this time we are waiting for a Final Disposition of the charge.

MOTION: After discussion, Dr. Friday-Stroud made a motion to grant licensure upon a contact made to PRN in 30 days, evaluation completed in 60 days and compliance with recommendations in 90 days or the application will be denied. The motion was seconded by Mr. Mitchell and carried 5/0.

13. Codie Wilson, Registered Respiratory Therapist

Ms. Wilson was present.

Ms. Wilson was initially noticed on August 24, 2022. She requested that the Board Chair review her file for a determination due to being unable to attend the October meeting.

The Board Chair required her appearance on August 27, 2022.

MOTION: After discussion, Mr. Frey made a motion to grant licensure without conditions. The motion was seconded by Mr. Mitchell and carried 5/0.

14. Adam John Wilson, Registered Respiratory Therapist

Mr. Wilson was present.

Mr. Wilson was noticed to appear at the October 14, 2022, Board Meeting due to recency of the DUI charge.

The Board requested the final disposition of his upcoming court date and documentation to show proof of attending a program that would evaluate him on a similar level to PRN.

The Board delegated the review of the documents to the Board Chair once received.

If the Board chair cannot make a sufficient determination, appearance at the next meeting would not be required for a full board review of documentation.

Mr. Wilson waived his 90 days to stop Board action.

MOTION: After discussion, Mr. Frey made a motion to accept Mr. Wilson's waiving of the 90-day requirement and stop Board action. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

15. Connie Ponton, Registered Respiratory Therapist

Ms. Ponton was not present.

Ms. Ponton was noticed to appear at the October 14,2022 meeting.

MOTION: After discussion, Mr. Mitchell made a motion to grant licensure without conditions. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

16. Cindy Arbouine, Certified Respiratory Therapist

Ms. Arbouine was not present.

Board appearance is required per the board chair.

MOTION: After discussion, Mr. Mitchell made a motion to grant licensure without conditions. The motion was seconded by Dr. Friday-Stroud and carried 5/0.

Ms. Comfort was noticed to appear at the October 14, 2022, meeting on August 16, 2022.

MOTION: After discussion, Mr. Mitchell made a motion to require Ms. Comfort's appearance at the January 2023 meeting. The motion was seconded by Mr. Frey and carried 5/0.

18. Nickolas Schey, Certified Respiratory Therapist

Mr. Schey was not present.

Mr. Schey appeared at the July Board Meeting and was sent a Notice of Intent of Contingent Approval upon a 30/60/90 PRN evaluation.

Mr. Schey sent a statement to withdraw his application on September 1st, 2022.

MOTION: After discussion, Mr. Mitchell made a motion to accept the withdrawal request. The motion was seconded by Mr. Frey and carried 5/0.

MOTION: After discussion, Dr. Friday- Stroud made a motion to vacate the previous order. The motion was seconded by Mr. Frey and carried 5/0.

19. Stephen R. Speelman, Certified Respiratory Therapist

Mr. Speelman was not present.

The Board Chair required Mr. Speelman's appearance. A notice to appear was sent on July 25th, 2022. Mr. Speelman did not report his discipline on his application.

MOTION: After discussion, Mr. Mitchell made a motion to require Mr. Speelman's appearance at the January 2023 meeting. The motion was seconded by Mr. Frey and carried 5/0.

APPLICANT RATIFICATION LISTS

20. Certified Respiratory Therapists

MOTION: Mr. Frey made a motion to ratify the list of 76 names, beginning with Alexis Davidson and ending with Steven Tull for CRT licensure by endorsement. The motion was seconded by Ms. Hom and carried 5/0 (Exhibit A).

21. Registered Respiratory Therapists

MOTION: Mr. Frey made a motion to ratify the list of 380 names, beginning with Madison Shays and ending with Jose Argueta for RRT licensure by endorsement. The motion was seconded by Ms. Hom and carried 5/0 (Exhibit B).

22. Exemption from Employment Disqualification

The board has delegated authority to staff to administratively review and approve exemption applications that meet certain criteria. The list of administratively approved exemptions is included for ratification.

MOTION: Mr. Frey made a motion to ratify Michelle P. Rainbird and Eric V. Thompson's, request for an exemption for disqualification from employment by delegation of the authority from the Board for staff to administratively review and approve exemption applications that meet certain criteria. The motion was seconded by Ms. Hom and carried 5/0.

23. New Continuing Education Providers

MOTION: Ms. Hom made a motion to ratify the 3 names, Relias LLC, NETCE-NETCE.COM and Adventhealth Deland, as new continuing education providers. The motion was seconded by Mr. Mitchell and carried 5/0.

RULE DISCUSSION AND/OR DEVELOPMENT

24. Rule 64B32-6.004, F.A.C, Procedures for Approval of Attendance at Continuing Education Courses

In 2017, the Board amended the Continuing Education rule approving CE provided by certain groups. The phrase "on or before April 1, 2017" was added to the rule.

Board staff has received inquiries about the rule language as it does not allow CE from these groups that was approved after April 1, 2017.

Staff hopes the suggested rule language, if approved, will become effective prior to the renewal in May of 2023.

The Board is also encouraged to discuss this phrase to determine if it wants to continue to bar CE for these types of courses. "(2) Excluding any recertification, review, refresher, or preparatory courses, all licensees shall be awarded continuing education hours for:"

Proposed Rule Language:

64B32-6.004 Procedures for Approval of Attendance at Continuing Education Courses.

(1) During the license renewal period of each biennium, an application for renewal will be mailed to each licensee at the last address provided to the Board. Failure to receive any notification during this period does not relieve the licensee of the responsibility of meeting the continuing education requirements. The licensee must retain such receipts, vouchers, certificates, or other papers as may be necessary to document completion of the appropriate continuing

education offerings listed on the renewal form for a period of not less than 4 years from the date the offering was taken. Failure to document compliance with the continuing education requirements or the furnishing of false or misleading information regarding compliance shall be grounds for disciplinary action pursuant to Section 468.365(1)(a), F.S.

- (2) Excluding any recertification, review, refresher, or preparatory courses, all licensees shall be awarded continuing education hours for:
 - (a) Attendance at all offerings that are approved on or before subsequent to April 1, 2017, by:
 - 1. The American Association for Respiratory Care (AARC),
 - 2. The Florida Society for Respiratory Care; and,
- 3. The Accreditation Council for Continuing Medical Education (ACCME), the American and Florida Thoracic Societies, the American College of Cardiology, the American College of Chest Physicians, the American and Florida Societies of Anesthesiologists, the American and Florida Lung Association, the National Society for Cardiopulmonary Technologists, the American Heart Association, the American Nurses Association, the Florida Nurses Association, and the Florida Board of Nursing.
- (b) Attendance at all offerings that are conducted by institutions approved on or before subsequent to April 1, 2017, by the Commission on Accreditation for Respiratory Care (CoARC);
- (c) Successful completion, for the first time, of any college or university course, but only if such course is part of the curriculum within an accredited respiratory therapy program and is provided by that accredited respiratory therapy program, up to the maximum hours permitted by subsection (3), of this rule.
- (d) Successful completion of the following certification classes, up to a maximum total of 16 hours per biennium;
 - 1. Advanced cardiac life support,
 - 2. Neonatal resuscitation program,
 - 3. Pediatric advanced life support,
- 4. Any course offered by the National Board of Respiratory Care (NBRC) on or before subsequent to April 1, 2017.
- (e) Successful completion of the following recertification classes, up to a maximum of 8 hours per biennium;
 - Advanced cardiac life support,
 - 2. Neonatal resuscitation program,
 - 3. Pediatric advanced life support.
- (f) Attendance at scheduled public meetings of the Board of Respiratory Care, at which disciplinary hearings are conducted, and where the licensee has not been required by the Board to appear, up to a maximum of 8 continuing education hours in risk management per biennium.

- (3) Credit for two (2) hours shall be awarded for completion of a FEMA Emergency Management/Preparedness continuing education course approved by FEMA on or before subsequent to April 1, 2017, that covers the following topics: natural disasters, manmade disasters and bioterrorism, pandemic flu, and respiratory care disaster response.
- (4) Each licensee who is presenting a continuing education course as either the lecturer of the offering or as author of the course materials may earn a maximum 12 hours of continuing education credit per biennium. Each licensee who is either participating as a lecturer of a continuing education course or an author of a continuing education program may receive credit for the portion of the offering he/she presented or authored to the total hours awarded for the offering.
- (a) Continuing education credit may be awarded to a lecturer or author for the initial presentation of each program only; repeat presentations of the same continuing education course shall not be granted credit.
- (b) In order for a continuing education credit to be awarded to each licensee participating as either faculty or author, the format of the continuing education program must comply with all applicable sections of this rule chapter.
- (c) The number of hours to be awarded to each licensee who participates in a continuing education program as either a lecturer or author is based on the definition of "hour" employed within this rule chapter.
- (5) Former members of the Board's Probable Cause Panel shall receive five (5) hours of continuing education credit in risk management per biennium for their service on the Panel.
- (6) The Board shall make exceptions for licensee from the continuing education requirements, including waiver of all or a portion of these requirements or the granting of an extension of time in which to complete these requirements, upon a finding of good cause by majority vote of the Board at a public meeting following receipt of a written request for exception based upon emergency or hardship. Emergency or hardship cases are those: (1) involving long term personal illness or illness involving a close relative or person for whom the licensee has care-giving responsibilities; (2) where the licensee can demonstrate that the required course(s) are not reasonably available; and (3) where the licensee can demonstrate economic, technological, or legal hardships that substantially relate to the ability to perform or complete the continuing education requirements.

MOTION: After discussion, Dr. Friday- Stroud made a motion to accept the rule language as presented and proceed with rule making. The motion was seconded by Ms. Hom and carried 5/0.

MOTION: Dr. Friday-Stroud made a motion to find the proposed rule amendments will not be likely to increase regulatory costs directly or indirectly to any entity in excess of \$200,000 within 1 year after the implementation of the rule. The motion was seconded by Mr. Frey and carried 5/0.

MOTION: Dr. Friday-Stroud made a motion to find that a violation of this rule or any part of this rule will not designate as a minor violation. The motion was seconded by Ms. Hom and carried 5/0.

MOTION: Dr. Friday-Stroud made a motion that this Rule will not involve a sunset provision. The motion was seconded by Mr. Frey and carried 5/0.

25. ACESO Respiratory Review and Remediation

Ms. Nelson is inquiring as to the need for a Board approved remedial course to assist in passing the exams required to obtain the NBRC credentials.

She has provided preliminary information on the course content and would provide the full curriculum if the Board indicates interest.

The Florida Laws and Rules do not require remedial coursework following a specified number of unsuccessful attempts on the exams. No authority exits to allow the Board to mandate a remedial

The Board took no action.
