DISCIPLINARY PROCEEDINGS

MOTION FOR BOARD'S FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

2. Peter E. Bernat, RRT., Case No: 2014-02587 (PCP, Frey & Barrett)

Respondent was not present, nor represented by Counsel.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violations: **Count 1:** Section 468.365 (1)(c), Florida Statutes (2014), by being convicted of found guilty of, or entering a plea of nolo contendere to, regardless of adjudication, a crime in any jurisdiction which directly related to respiratory care service. **Count 2:** Section 468.365 (1)(x), Florida Statutes (2014), through a violation of 456.072(1)(x) Florida Statutes (2014), for failing to report to the board, in writing within 30 days after the licensee has been convicted or found guilty of, or entered plea of nolo contendere to, regardless of adjudication.

The case was presented as a Hearing Not Involving Disputed Issues of Material Fact, which requires the Board to impose whatever discipline upon the Respondent's license that the Board deems appropriated and to assess costs of the investigation.

MOTION: Dr. Friday-Stroud made a motion to accept the investigative report into evidence for the purpose of imposing penalties. The motion was seconded by Ms. Nunez and carried 4/0.

MOTION: Dr. Friday-Stroud made a motion to make a finding that the Respondent was properly served and has requested an informal hearing. The motion was seconded by Ms. Nunez and carried 5/0.

MOTION: Dr. Friday-Stroud made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Ms. Nunez and carried 4/0.

MOTION: Dr. Friday-Stroud made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Respiratory Care Practice Act. The motion was seconded by Ms. Nunez and carried 4/0.

MOTION: After discussion, Dr. Friday-Stroud made a motion to impose the following penalties:

- Revocation of license
- Costs of 425.00 to be paid within 90 days of the filing of the Final Order

The motion was seconded by Ms. Nunez and carried 4/0.

MOTION FOR BOARD'S FINAL ORDER BY SETTLEMENT AGREEMENT

3. Robert Edwin Petersen, RRT., Case No: 2015-11848 (PCP, Garcia & Barrett)

Respondent was present and sworn in by the court reporter.

Ms. Sykes summarized the case for the Board. Respondent was charged with the following violation: Section 468.365 (1)(x), Florida Statutes (2014), through a violation of Section 456.072 (1)(hh), Florida Statutes, by being terminated from a treatment program for impaired practitioners, which is overseen by an impaired practitioner consultant as described in section 456.076.

The case was presented as a Settlement Agreement that would impose the following penalties:

Appearance

- Costs to be paid within two (2) year of the filing of the Final Order
- The Respondent's license to practice respiratory care in the State of Florida is hereby SUSPENDED until such time as he demonstrates the ability to practice respiratory care with reasonable skill and safety. Such demonstration of skill and safety shall include an evaluation by the Professionals Resource Network (PRN). The Respondent shall appear before the Board with said PRN evaluation and the Board shall make the determination of whether Respondent is safe to practice respiratory care with reasonable skill and safety. The Board retains jurisdiction in this matter to impose terms and conditions upon reinstatement of Respondent's license, including, but not limited to, a period of probation with said terms and conditions to be set at the time of reinstatement.

MOTION: Dr. Friday-Stroud made a motion to accept the Settlement Agreement with Mr. Petersen agreeing to accept the modification, that upon receipt of a positive evaluation to the Board office, from PRN affirming that the Respondent has been determined safe to practice respiratory care with reasonable skill and safety, the suspension shall be lifted by the Board Chair as authorized by the Board. If not, the suspension with remain in place until such time as him determining to the Board that he is safe to practice. The motion was seconded by Ms. Nunez and carried 4/0.

MOTION: Dr. Friday-Stroud made a motion to access the costs of \$1,500.00 to be paid within two (2) years of the filing of the Final Order. The motion was seconded by Ms. Nunez and carried 4/0.

MOTION: Ms. Sherrod made a motion to allow prosecution to continue prosecuting year old cases. The motion was seconded by Ms. Nunez and carried 6/0.

ADMINISTRATIVE PROCEEDINGS

PERSONAL APPEARANCE PURSUANT TO §456.013(3) (c), F.S.

5. Joseph William Leo, Registered Respiratory Therapist

Mr. Leo was not present nor represented by Counsel.

He was requested to appear before the board due to the "yes" answer in the criminal history section of his application at the January 8, 2016 Board meeting. Mr. Leo was not present. The Board voted, requiring his appearance at the April 8, 2016 regularly scheduled meeting. Mr. Leo fail to appear at this meeting.

MOTION: After discussion, Ms. Nunez made a motion to deny licensure due to Mr. Leo not complying with the Order requiring him to appear before this April 8, 2016, scheduled meeting to discuss his criminal history.

The motion was seconded by Ms. Sherrod and carried 6/0.

6. Tricia Jane Winter, Registered Respiratory Therapist

Ms. Winter was not present nor represented by Counsel.

She was requested to appear before the board due to the "yes" answer in the criminal history section of her application. Ms. Winter sent notice that she was not be able to attend the meeting due to conflicts and asked to be placed on the next regularly scheduled meeting.

MOTION: After discussion, Dr. Friday-Stroud made a motion to table the application until the next regularly scheduled meeting. The motion was seconded by Ms. Sherrod and carried 6/0.

APPLICANT RATIFICATION LISTS

7. Certified Respiratory Therapists

MOTION: Mr. Garcia made a motion to ratify the list of 36 names (*Exhibit A*), beginning with David Dayton Tesoro and ending with Taressa Stanfield for CRT licensure by endorsement. The motion was seconded by Ms. Nunez and carried 6/0.

8. Registered Respiratory Therapists

MOTION: Ms. Sherrod made a motion to ratify the list of 137 names *(Exhibit B)*, beginning with Alicia Lynn Riley and ending with Jenifer Roberson Anderson for RRT licensure by endorsement. The motion was seconded by Ms. Nunez and carried 6/0.

9. Continuing Education Providers

MOTION: Ms. Sherrod made a motion to ratify the 5 names (*Exhibit C*), for CE providership, beginning with Sandra M. Johnson and ending with Memorial Hospital Jacksonville. The motion was seconded by Ms. Nunez and carried 6/0.

10. Exemption From Disqualification Ratification List

MOTION: Ms. Sherrod made a motion to ratify the one name, Gordon Lewis Arendall Jr. (*Exhibit D*), for exemption for disqualification from employment by delegation of authority from the Board for

staff to administratively review and approve exemption applications that meet certain criteria. The motion was seconded by Ms. Nunez and carried 6/0.

NEW BUSINESS

11. Smoking Cessation Presentation

At the October 2015 meeting, the Board expressed interest in inviting, Ms. Amy Cober, RD LD MPRH CTTS, to the Board meeting to further talk on this topic. This item has been brought forward to this April 2016 meeting to allow Ms. Cober provide a presentation on smoking cessation and how respiratory therapists can contribute.

Ms. Cober was present and gave a detailed presentation of tobacco addiction, tobacco treatment and also provided literature on the smoking cessation topic. She expressed the interest of tobacco treatment being provided as formal educational training in the accredited Respiratory Care programs. The Board Chair mentioned that he would be reaching out to Ms. Cober in the future, regarding the educational interest of the tobacco use treatment. This topic with also be discussed later in the agenda.

12. 2016 Legislative Update

The Board reviewed the following bills considered during the legislative session.

- CS/CS/HB 941 Department of Health Bill
- CS/CS/HB 7087 Telehealth.
- HB 981 Statement of Estimated Regulatory Costs (SERC).
- SB 1150 and HB 953 related to rulemaking authority. These bills did not pass.

No action required.

13. CS/CS/HB 941 – Department of Health

The Board reviewed CS/CS/HB 941, which contained the following provisions relevant to respiratory care

- 456.013(7) Medical errors CE no longer required at initial licensure. Medical errors CE will
 only be required at renewal.
- 456.024 Multiple changes related to expedited licensure for Members of the United States Armed Forces and their spouses
- 456.057 Allows the Department to contract with a third party to be the custodian of medical records in the event of the death of a practitioner, the mental or physical incapacitation of a practitioner or the abandonment of medical records by a practitioner
- 456.0361 Electronic continuing education tracking system. Department may not renew a license until a licensee complies with all applicable CE requirements
- 456.0635 Applicants with a 456.0635 conviction (certain drug and fraud convictions) will
 no longer have an exemption when they were enrolled in an educational training program
 on or before July 1, 2009

The following rule changes are contingent upon the bill becoming law.

• Rule 64B32-2.001, F.A.C., License by Endorsement

MOTION: After discussion, Dr. Friday-Stroud made a motion to approve the proposed revisions and open Rule 64B32-2.001 for development to update the application revision contingent upon the bill becoming law. The motion was seconded by Ms. Nunez and carried 6/0.

Rule 64B32-6.006, F.A.C., AIDS Education and Medical Error Prevention Education

MOTION: After discussion, Dr. Friday-Stroud made a motion to approve the proposed revisions and open Rule 64B32-6.006 for development contingent upon the bill becoming law. The motion was seconded by Mr. Frey carried 6/0.

MOTION: Dr. Friday-Stroud made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Mr. Frey and carried 6/0.

14. Board Outreach

Board members discussed "Board Outreach" activities. The Chair is to work with the Executive Director on a listing of activities or plan for future outreach to be presented at July meeting.

15. Strategic Plan for Respiratory Care

The Chair requested a discussion to determine if the Board wishes to develop a strategic plan directly to for the Florida Respiratory Care Board. He has provided a plan developed by the California Board as an example. The Board may develop a plan, a mission and other statements so long as they do not conflict with the Department of Health or the enabling statutes.

The Board suggested an on-line survey as a start. The members will prepare survey questions to send to the Board Staff, and come up with at least 5 survey questions to discuss.

The Board has asked the board staff to set up a conference call prior to the next full Board business meeting, to allow the members to start their strategic planning. Staff has been directed to set up a conference call for April 29, 2016 at 8:30 a.m.

REQUEST FOR CONSIDERATION OF EXEMPTION FOR DISQUALIFICATION FROM EMPLOYMENT

25. Warren Kevin Pullin, TT11682

Mr. Pullin was not present nor represented by Counsel.

He has submitted an application for Exemption from Disqualification to seek employment in a health care facility licensed under Chapter 400, Florida Statutes.

MOTION: After discussion, Mr. Colon made a motion to grant Mr. Pullin's request for an Employment Exemption from Disqualification. The motion was seconded by Mr. Frey and carried 4/2. Ms. Sherrod and Mr. Garcia opposed.

16. National Board for Respiratory Care Annual Meeting

The National Board for Respiratory Care (NBRC) is inviting one person to the 2016 annual meeting. The meeting will be held August 26-27, 2016 at the NBRC Executive Office in Olathe, Kansas. In case the primary representative is unable to attend, the Board should nominate an alternate representative also.

Motion: After Discussion, Ms. Nunez made a motion to select Mr. Garcia to attend the NBRC Annual meeting as a representative for the Florida Respiratory Care Board and Mr. Colon as the alternate. The motion was seconded by Dr. Friday-Stroud and carried 6/0.

RULE DISCUSSION AND/OR DEVELOPMENT

- 17. 64B32-6.001, F.A.C., Continuing Education Requirement
 - Limitation of Home-Study Course Hours

Proposed rule language as requested for Rule 64B32-6.001 (5), revisions to the continuing education rule to eliminate limits on home study course hours for renewal.

There is also information from J.B. Elsberry, RRT, Ph.D., with the Florida Respiratory Leadership Network expressing their concerns as the Board consider revision to this rule regarding home study.

The Florida Respiratory Leadership Network, along with the Florida Society for Respiratory Care with Dennis Willerth expressed their interests of the importance of preserving the minimal continuing education standard for the respiratory care profession in the ongoing effort to enhance patient safety. Mr. Cesar Garza from Texas, Ms. Sandra Smith with Florida Medical Education Services, Tami Bannister and Mr. Nicholas DiRubbo was also allowed to speak on the subject matter.

MOTION: After discussion, Ms. Nunez made a motion to approve the proposed revisions and open Rule 64B32-6.006 for development, deleting the limitation on home study/self-study course hours for renewal. The motion was seconded by Mr. Colon and carried 5/1. Ms. Sherrod opposed.

MOTION: Ms. Colon made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Ms. Nunez and carried 5/1. Dr. Friday-Stroud opposed.

• Smoking Cessation Continuing Education Requirement

At the January 2016 Respiratory Care meeting, the Board expressed interest in requiring continuing education hours for smoking cessation and asked the Board Counsel to review the issue to determine if the Board has authority to do so. Board Counsel reported he did not see any legal impediment to the Board adding rule language regarding continuing education on smoking cessation. Ms. Cober was present and stated that the correct name for this topic is "Tobacco Use Treatment".

The Board proceeded with discussion on the topic and would like Mr. Dolan to work on language at the July 2016 meeting, for the Tobacco Use Treatment course, it will be a one (1) hour course and making it a requirement for the biennium ending May 31, 2019.
