**DISCIPLINARY PROCEEDINGS**

**MOTION FOR DETERMINATION OF WAIVER AND FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT**

1. Andre S. Gued, CRT., Case No: 2018-19739 (PCP, Broeker and Nunez)

Respondent was not present nor represented by Counsel.

Ms. Prescott summarized the case for the Board. Respondent was charged with the following violations: Section 468.365 (1)(x), Florida Statutes (2014) through a violation of Section 456.072(1) (x), Florida Statutes (2014), for failing to report his pleas and /or conviction (s) to the Board in writing within 30 days.

The case was presented as a Hearing Not Involving Disputed Issues of Material Facts and determination of Respondent's waiver of right to request an informal hearing by default.

**MOTION:** Dr. Friday-Stroud made a motion to accept the investigative report and exhibits into evidence for the purposes of imposing penalty, making a finding that the Respondent was properly served and has waived his right to a formal hearing, adopted the findings of fact that is set forth in the Administrative Complaint. The motion was seconded by Ms. Hom and carried 5/0.

**MOTION:** Dr. Friday-Stroud made a motion to adopt the conclusions of Law as set forth in the Administrative Complaint and that this constitutes a violation of the Practice Act. The motion was seconded by Ms. Hom and carried 5/0.

**MOTION:** After discussion, Dr. Friday-Stroud made a motion to impose the following penalties:

Reprimand, \$300 Fine and respondent shall complete a two-hour continuing education course on Florida Respiratory Care Rules and Laws. The motion was seconded by Ms. Hom with a vote of 2/3 opposing. Motion failed.

Mr. Mitchell made a motion to impose the following penalties:

- Reprimand
- Fine of \$500.00
- Respondent shall complete a two-hour continuing education course on Florida Respiratory Care Rules and Laws.

The motion was seconded by Mr. Garcia with a vote of 3/2 opposing, motion carried.

Mr. Frey made a motion that the fine and continuing education shall be completed within one (1) year of the filing of the Final Order. The motion was seconded by Mr. Mitchell and carried 5/0.

**MOTION:** Dr. Friday-Stroud made a motion to access the costs of \$134.26 to be paid within one year of the filing of the Final Order. The motion was seconded by Ms. Hom and carried 5/0.

Ms. Prescott summarized the case for the Board. Respondent was charged with the following violations: Section 456.072(1)(k)(z)(dd) hh), Florida Statutes, through a violation of Section 468.365 (1)( l)(w)( x),Florida Statutes, by filing comply with IPN directives.

Respondent was charged with the following violations: Section 456.072(1)(x), Florida Statutes, by violating Section 468.365 (1)(q), Florida Statutes (2017) and/or 456.072(1)(v), Florida Statutes (2017) and/or Section 456.063(1), Florida Statutes (2017).

The case was presented with 3 exceptions to the Department of Administrative Hearings Recommended Order.
